And Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs) and Phthalates content were determined by Gas Chromatographic-Mass Spectrometric (GC-MS).

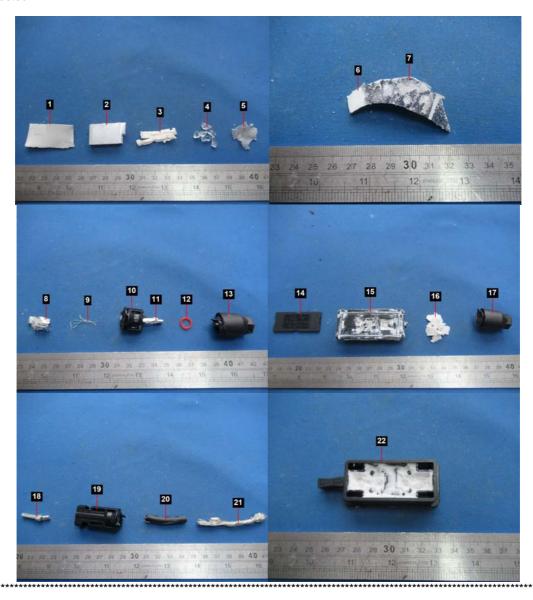
